PUPPY CONTRACT

Sandra's English Bulldogs guarantees that the puppy sold is in good physical health on the day of purchase. All necessary shots and dewormings have been done. The purchaser agrees to take this puppy to a licensed veterinarian of their choice within 3 business days for a health check. At this time, please have your vet do any test he/she feels necessary to determine that this puppy is healthy and free of any illness or congenital life threatening disorders.

Sandra's English Bulldogs must be informed immediately of this examination with all diagnosis if there should be any. Should the puppy be determined unfit for purchase due to illness, disease, or congenital disorder, the cause of which is clearly attributable to the seller, the puppy may upon presentation of a written diagnosis from said veterinarian be returned for another puppy of equal value by the seller.

Puppies that are shipped are at risk of coccidian and kennel cough which is common in puppies and caused by bacteria. Kennel cough is self limiting and like the common cold, it must run its course. Full recovery is expected and kennel cough is not life threatening. So, if you plan to have your puppy shipped instead of picking it up, you need to be aware of this.

Sandra's English Bulldogs also offer a replacement guarantee on our puppies up to 12 months of age. If the puppy develops a congenital/hereditary life threatening disorder, we will replace the puppy with another puppy of the same sex, breed, and equal value. If the dog has been neutered or spayed, the replacement puppy will also be neutered, spayed, or on limited registration at our first opportunity provided the condition below are met and kept by the buyer:

1. Buyer will offer this puppy back to breeder first if ever for sale or in need of placement.
2. If puppy dies within one month, a replacement will be offered providing the buyer has a veterinarian's autopsy report which indicates that a congenital or hereditary defect was the cause of death. Buyer pays all shipping cost involved in obtaining a replacement puppy.
3. Buyer agrees to provide routine veterinary care of this puppy. Including proper vaccinations, routine worm checks, heartworm treatments, and records of such care should buyer have to return puppy for replacement.
4. Buyer understands contract will be void if buyer fails to provide routine veterinary care, if puppy is sold, transferred, or injured by accident or neglect.
5. This guarantee does not cover any common puppy ailments such as worms, vitamin deficiencies, any viral bacterial diseases or disorders brought on by parasites. Guarantee does not cover what in the bulldog breed we consider normal: Cherry Eye, entropion, loose hips or knees, or skin allergies such as demodectic mange.

6. Sandra's English Bulldogs will not be responsible for veterinary fees or costs. Buyer is aware that owning a puppy means regular trips to the vet and, understands that he/she will be responsible for all payments.
7. There is no guarantee or warranty that the buyer will be able to show or breed the puppy regardless of show or breeding potentials. Sandra's English Bulldogs is not responsible for temperament issues as they can be caused by lack of training, discipline, or proper dog socialization which is determined by every dog's personality.
8. This contract is valid only for the original buyer and puppy. It is not transferable.
9. If a replacement puppy is given, you must return all AKC papers with the puppy to Sandra's English Bulldogs and sign it over to Sandra Stafford as the new owner. The replacement puppy's AKC papers will be signed over to you.
10. Buyer understands and agrees that bulldogs are inside dogs and require air-conditioned living conditions to prevent over-heating.
11. There is a \$350.00 shipping cost if the puppy is going to be shipped.

I, the buyer, have read this contract, and understand fully the contents thereof and acknowledge receipt of it. We are not relying on verbal statements not contained herein.

We accept a \$300.00 non-refundable deposit that will hold the puppy you pick until ready for placement. The remaining balance is due before the puppy is 8 weeks old unless other written agreements have been made. If placing a deposit on an upcoming litter for a certain pick, the deposit is refundable if the said bitch doesn't produce any puppies or the puppy you pick dies. We cannot guarantee color of puppies. Seller has the right to refuse to sell to any buyer at any given time and seller will refund deposit in this case.
